The Station Wages Sub-Division met on the 1^{st} of August 2016. Some of the issues that were tabled at the meeting were taken up with Sydney Trains at the Consultative meeting held on the 17^{th} October 2016.

Some of these issues were:

- No trauma policy for station staff
- Sydney Trains not providing comfort breaks
- Station Staff being threatened over IV results
- Sydney Trains disregarding the consultation clause as per the EA.

In addition there were discussions about the amalgamation of the wages and salary picnic committees.

The outcomes of this discussion resulted in a resolution being passed and endorsed.

Sydney Trains Stations Consultative Meetings

The quarterly scheduled consultative meeting with Sydney Trains was delayed as a result of the last staff review. As such, the consultative meeting was rescheduled to the 17th October 2016.

The agenda is led by issues that were tabled at the Station Wages Sub-Divisional meetings and by individual members via their delegates.

The agenda of the quarterly meeting was very extensive as a consequence of the delay in scheduling this meeting.

There were many issues that were addressed but it is worth noting that a number of items were left outstanding due to time constraints of the meeting.

Sydney Trains Station Staff Review Outcome

The outcome for the Sydney Trains Station Staff reviews were as follows:

- 40 Stations were Reviewed along with the Lost Property Office in Pitt St
- 23 members elected to take VR
- 91 members were translated into other position locations.
- 117 Positions were abolished from stations
- 39 Positions were saved due to the review teams negotiations.

Members are reminded that these reviews have been initated by Sydney Trains.

Trish Doyle - Stands up for Rail Workers

On the 22nd September Trish Doyle ALP Member of Parliament for the Blue Mountains addressed Parliament.

In the address Ms. Doyle reinterated the request she has been making to the Minister for Transport and Infrastructure to add extra capacity for train passengers traveling the Blue Mountains. The request for extra capacity is due to the amount of passengers that travel up to the mountains on weekdays and weekends being restricted to standing room only.

The weekends were given particular attention by Ms Doyle due to the trains being made up of four (4) carriages combined with the amount of customers made up of day trippers, tourists and the local community.

Ms. Doyle outlined that this issue could be addressed by running six or eight car trains instead of four. However, Ms. Doyle stated that she suspected the reason the Transport Minister is so quiet about weekend over crowding issues is due to NSW Trains having to increase the staffing to perform 'Repeater' duties. One of the consequences of this would be additional staff penalty rates.

In addition, Ms Doyle spoke about the new Intercity Fleet that is to replace the V-set on the Blue Mountains, Newcastle and Illawarra lines. The concern with the new Intercity Fleet is that they are being designed to run without a guard from the date of their introduction.

Ms. Doyle is quoted as stating:



"Not only do the cheapskates in the Baird Government refuse to adequately staff our trains on weekends; they are busily making plans to

lay off train guards altogether from 2019."
